SKI AND SNOWBOARD SCHOOL
LIABILITY RELEASE AND INDEMNITY AGREEMENT

Please read carefully! This is a release of liability and waiver of certain legal rights.

The below named participant ("Participant") understands that skiing and snowboarding ("Skiing") can be hazardous and that injuries are common. Participant accepts and assumes the risks associated with Skiing, including, but not limited to, weather, variations and steepness in terrain, terrain features and parks, snow/ice conditions, surface or subsurface conditions, bare spots, creeks and gullies, forest growth, avalanches, snow immersion, rocks, stumps, the use of lifts, collisions with natural or manmade objects or other persons, grooming and snowmobile equipment, lift towers and other structures and their components, falling, loss of control, selection of terrain, and exceeding one's ability. Participant is the sole judge of his/her ability to negotiate any terrain or perform any maneuver, whether or not directed by anyone else. Participant hereby expressly assumes all risk of injury and death associated with Skiing.

In consideration for the use of any area facilities, services, and premises, Participant hereby agrees to release and indemnify Cooper Spur and Mt. Hood Meadows Oreg., LLC, and their owners, partners, employees, directors, officers, and agents ("Cooper Spur") from all claims by or on behalf of Participant against Cooper Spur arising directly or indirectly out of Participant's use of Cooper Spur's Ski and Snowboard School services and/or the area facilities, services, or premises. This release only includes claims arising from, ordinary negligence on the part of Cooper Spur. Participant also agrees to indemnify (including costs and attorney fees) Cooper Spur for any claim brought on behalf of any minor named below.

INJURIES may result as a consequence of participant in a ski school class. The Participant therefore assumes the responsibility of skiing under control at all times and is the sole judge of their ability to ski any terrain or perform any maneuver whether or not directed by a representative of the Cooper Spur Ski School.

If I am signing on behalf of a minor, I accept full responsibility for all medical expenses incurred as a result of the minor's participation in Cooper Spur's class. I also understand that ski school students of any age, in some cases, may be asked to board the chair lift alone or with another person and may not always ride with an instructor.
